CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LOUIS F. ANDERSON ROOM 104 JUSTICE BLDG. ROSEBURG, OR 97470

confirms the right to use the waters of COW CREEK, a tributary of SOUTH UMPQUA RIVER for the purpose of IRRIGATION of 79.2 ACRES.

This right was perfected under Permit S-890. The date of priority is JULY 21, 1911. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.99 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-SEVENTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.5 acrefeet per acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
