The use shall conform to such reasonable rotation system as may be ordered by the proper State office.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the new points of diversion shall not exceed the quantity of water available at the old point of diversion described as follows:

The water user shall maintain a weir, or other suitable device for measuring the water to which the water user is entitled.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described.
