## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MAPLE LAKE LIVESTOCK CO. INC. PO BOX 448 MADRAS, OR 97744

NORTHWEST FARM CREDIT SERVICES, ACA PO BOX 607 REDMOND, OR 97756

confirms the right to use the waters of WILLOW CREEK, a tributary of DESCHUTES RIVER, for SUPPLEMENTAL IRRIGATION OF 16.9 ACRES. The use allowed herein may be made any time when water can be put to beneficial use by irrigation, either from immediate crop growth or forecast requirements to raise the soil moisture to field capacity in the soil profile to be utilized by plant growth in the subsequent growing season.

This right was perfected under Permit S-45102. The date of priority is APRIL 17, 1980. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.24 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right exiting for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the period from April 1 to September 30, and shall be further limited to a diversion of not to exceed 1.5 acre-feet per acre for each acre irrigated from October 1 to March 31, provided further that the right allowed herein shall not exceed 4.0 acre-feet for each acre irrigated in any one year. The use of water during the period from October 1 to March 31 as authorized herein shall not establish priority of right as against future appropriations of surface water for beneficial uses or for storage for such beneficial uses other than similar rights for irrigation from October 1 through March 31, provided further that the right allowed herein for supplemental irrigation shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
