CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

THEODORE AND GENEVA RABERN
PO BOX 595
JACKSONVILLE OR 97530

confirms the right to use the waters of HUMBUG CREEK, a tributary of the APPLGATE RIVER, for IRRIGATION OF 0.5 ACRE, DOMESTIC AND STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Jackson County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 4, at Page 1. The date of priority is 1871.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.007 CUBIC FOOT PER SECOND, if available at the original point of diversion (Benedict Ditch) on Humbug Creek.

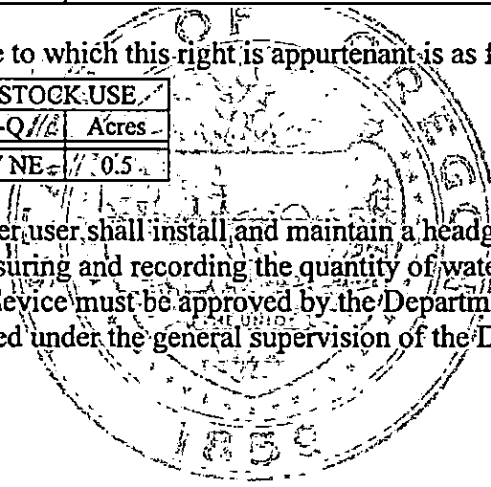
The point of diversion is located as follows:

A description of the place of use to which this right is appurtenant is as follows:

IRRIGATION, DOMESTIC AND STOCK USE

Prior to diverting water, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.



This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Prior to diverting water, the water user shall install and maintain a fish screen or fish by-pass device, as appropriate, at the new point of diversion. The type and plans of the screen or by-pass device must be approved by the Oregon Department of Fish and Wildlife prior to beginning of construction, and shall be installed under the supervision of the Department of Fish and Wildlife.

The quantity of water diverted at the new point of diversion shall not exceed the quantity of water lawfully available at the original point of diversion (Benedict Ditch) on Humbug Creek.

This certificate is issued to confirm an HISTORIC CHANGE IN POINT OF DIVERSION approved by an order of the Water Resources Director entered AUG 07 2018, approving Transfer Application T-12683, and together with Certificate 93848, supersedes Certificate 16427, State Record of Water Right Certificates.
