CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

VANDEHAY FARMS INC.  
21408 NW PIHL RD  
BANKS, OR 97106

confirms the right to use the waters of WEST FORK DAIRY CREEK, a tributary of DAIRY CREEK, for IRRIGATION of 4.1 ACRES AND SUPPLEMENTAL IRRIGATION OF 59.9 ACRES.

This right was perfected under Permit S-13388. The date of priority is DECEMBER 19, 1938. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.800 CUBIC FEET PER SECOND (CFS), BEING 0.051 FOR IRRIGATION AND 0.749 CFS FOR SUPPLEMENTAL IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
