CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ARCHIBALD C MCINTYRE MT HOOD, OR 97041

confirms the right to use the waters of A SPRING for Tract 1, a tributary of N. Branch Graham Creek, and Branch Graham Creek for Tract 2, for IRRIGATION AND DOMESTIC for 9.05 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Hood River County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 6, at Page 200. The date of priority is 1907.

The points of diversion are located as follows:

The amount of water to which such right is entitled, for the purposes aforesaid, is limited to an actual amount beneficially used for said purposes, and shall not exceed ONE-EIGHTIETH of one cubic foot per second, or its equivalent in case of rotation, and that the total quantity diverted during the irrigation season shall not exceed 3 acre-feet per acre, measured at the point of diversion.

A description of the place of use to which this right is appurtenant is as follows:

This certificate is issued to describe the right NOT modified by provisions of an order of the Water Resources Director, entered July _/9_, 2018, and recorded in Special Order Volume 108, Pages __911_, approving a partial cancellation of the right evidenced by Certificate 14989. This certificate supersedes Certificate 14989.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
