 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

J M MITCHELL
 JOSEPH OR 97846

confirms the right to use the waters of the WALLOWA RIVER, a tributary of the GRANDE RONDE RIVER for IRRIGATION of 261.6 ACRES, DOMESTIC, AND LIVESTOCK.

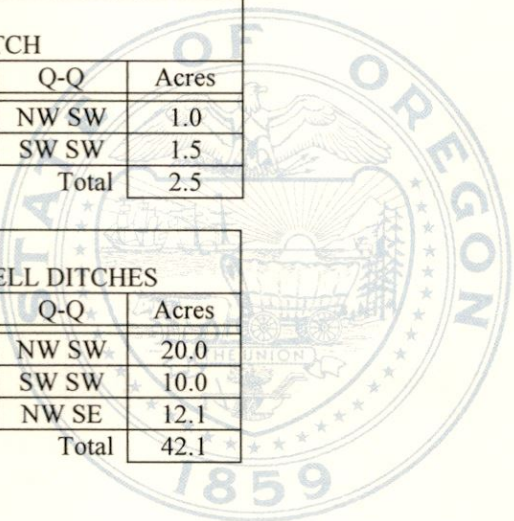
This right was confirmed by decree of the Circuit Court of the State of Oregon for Wallowa County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 5, at Page 186. The dates of priority are 1894 for Tract No. 1, August 30, 1880 for Tract No. 2, and August 14, 1900.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.5 acre feet per acre during any period of 30 days prior to July 31st of each year, and thereafter not to exceed 1.0 acre foot per acre during the entire remainder of the irrigation season; and said right shall be subject to all other conditions and limitations contained in said decree.

A description of the place of use to which this right is appurtenant is as follows:


