CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GERALD VAN DYKE 1000 SW 331ST AVE HILLSBORO, OR

confirms the right to use the waters of DAIRY CREEK AND RESERVOIR, CONSTRUCTED UNDER APPLICATION No. R-41992, PERMIT No. R-4809, a tributary of the TUALATIN RIVER, for IRRIGATION OF 29.0 ACRES AND SUPPLEMENTAL IRRIGATION OF 45.1 ACRES.

This right was perfected under Permit S-31708. The date of priority is MARCH 15, 1966. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.36 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-4809 and further limited to the use of stored water only on the land described as supplemental; and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
