confirms the right to use the waters of the Little Walla Walla River, tributary to the Walla River for IRRIGATION AND LIVESTOCK on 9.0 ACRES and IRRIGATION on 1.00 ACRE.

This right was perfected under by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 12 at Page 9. The priority dates are 1885 for 1.0 Acre and 1887 for 9.0 Acres.

The use is limited to 0.155 cubic foot per second, or its equivalent in case of rotation, measured at the point of diversion from the source. The amount of water used for irrigation is limited to a diversion of 1/65 of one cubic foot per second, or its equivalent for each acre irrigated during the irrigation season of each year.
