 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN CORREA

confirms the right to use the waters of ONE CLOSED (DRILLED) WELL AND ONE OPEN PIT WELL in the UMATILLA RIVER BASIN for IRRIGATION of 26.8 ACRES AND SUPPLEMENTAL IRRIGATION OF 15.4 ACRES.

This right was perfected under Permit G-11148. The date of priority is OCTOBER 8, 1985. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.53 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigations season of each year.

Use shall be limited to appropriation of water from the alluvium (gravel) aquifer above the basalt aquifer and shall be further limited to the extent that it does not impair or substantially interfere with prior ground water rights of others, and does not unduly interfere with surface water. Use of water under this right has been determined to have potential to cause substantial interference with surface waters in the Umatilla River and its tributaries. Whenever such interference exists with surface waters, the use of ground water allowed under this right shall be regulated in favor of surface waters of the Umatilla River and its tributaries.

A description of the place of use is as follows:

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484 and ORS 536.075. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 183.484, ORS 536.075 and OAR 137-004-0080, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate within three months after issuance of the certificate.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works shall be equipped with a useable access port, and may also include an air line and pressure gauge adequate to determine water level elevation in the wells at all times. When required by the Department the water user shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

The Director may require water level or pump test results every ten years.


Failure to comply with any of the provisions of this right may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the right.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described.
