confirms the right to use the waters of a WELL, tributary of the WALLA WALLA RIVER for SUPPLEMENTAL IRRIGATION on 39.1 ACRES.

This right was perfected under Permit G-10084. The priority date is MARCH 14, 1983. The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 0.436 cubic foot per second (cfs) or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of appropriation is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion not to exceed 3.0 acre-feet per acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state official.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

A description of the place of use to which this right is appurtenant is as follows:
