confirms the right to use the waters of WASTE WATER from the S½ NE¼ SE¼ Sec 34, and S½ N½ NW¼ SW¼ Sec. 35, T 6N, R 35 E W.M., tributary to the Walla Walla River for IRRIGATION on 18.6 ACRES.

This right was perfected under Permit S-9658. The priority date is 5/21/1930. The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 0.235 cubic foot per second (cfs) or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state official.

A description of the place of use to which this right is appurtenant is as follows:

This certificate is issued to correct a scrivener's error in the location of the point of diversion described on Certificate 92613. This Certificate supersedes Certificate 92613, and describes the water right modified by the provisions of an order of the Water Resources Director entered May 5, 2017, and recorded in Special Order Volume 104, Page 547, approving a petition by Walla Walla River Irrigation District under ORS 541.329 for mapping water rights within a district. This certificate supersedes Certificate 92613.
