CERTIFICATE OF WATER RIGHT

confirms the right to the use of water perfected under the terms of Permit G-10059. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the well(s). The specific limits and conditions of the use are listed below.

SOURCE OF WATER: FOUR WELLS IN THE GOOSE AND SUMMER LAKE BASIN

PURPOSE OR USE: SUPPLEMENTAL IRRIGATION OF 80.6 ACRES

MAXIMUM RATE: 1.01 CUBIC FEET PER SECOND (CFS), FURTHER LIMITED TO 0.31 CFS FROM LITTLE HOT WELL, IN ANY COMBINATION, NOT TO EXCEED A TOTAL OF 1.01 CFS

DATE OF PRIORITY: APRIL 19, 1983

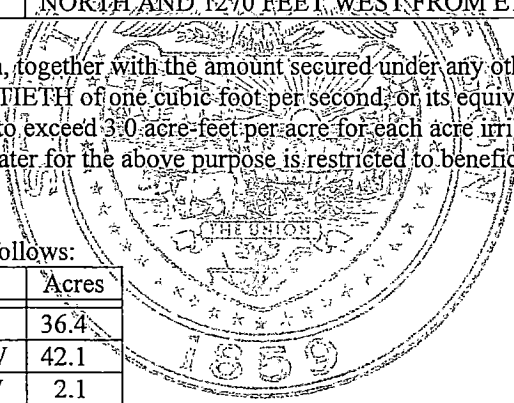

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

A description of the place of use is as follows:

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Measurement, recording and reporting conditions:

- A. The water user shall maintain, in good working order, a totalizing and instant read flow meter or other suitable measuring device as approved by the Director at each point of appropriation new and existing.
- B. The water user shall allow the watermaster access to the meters or measuring devices; provided however, where any meters or measuring devices are located within a private structure, the watermaster shall request access upon reasonable notice.
- C. The water user shall maintain a record of all water used each month, including the total number of hours of pumping, the total quantity pumped, and the categories of beneficial use to which water is applied. The record of use shall be submitted to the Department annually, or more frequently as may be required by the Director, and shall be submitted to the Watermaster upon request.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The works shall include an airline and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times.

The water user shall maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

The use of water shall be limited when it interferes with any prior surface or ground water rights.

The water user shall ensure that each well has been assigned an OWRD Well Identification Number (Well ID tag), which shall be permanently attached to the wells. The Well ID shall be used as a reference in any correspondence regarding the well, including any reports of water use, water level, or pump test data.


Wells with pumps shall be equipped with a minimum 3/4-inch diameter, unobstructed, dedicated measuring tube pursuant to figure 200-5 in OAR 690-200. If a pump has been installed prior to the issuance of this right and if static, water levels and pumping levels can be measured using an electrical tape, then the installation of the measuring tube can be delayed until such time that water levels cannot be measured or the pump is repaired or replaced.

The quantity of water diverted at the additional points of appropriation, together with that diverted at the original point of appropriation, shall not exceed the quantity of water lawfully available at the original point of appropriation.

Water shall be acquired from the same aquifer (water source) as the original point of appropriation.

This certificate is issued to confirm ADDITIONAL POINTS OF APPROPRIATION approved by an order of the Water Resources Director entered JULY 2, 2015, at Special Order Volume 96, Page 502, approving Transfer Application 11894, supersedes Certificate 89355, State record of Water Right Certificates.
