confirms the right to the use of waters as limited and conditioned below. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point(s) of diversion from the source.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Jackson County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 13, at Page 130.

PURPOSE OR USE: DOMESTIC USE EXPANDED, INCLUDING ONE-HALF ACRE OF LAWN AND NON-COMMERCIAL GARDEN

MAXIMUM RATE AND VOLUME: 0.009 CUBIC FOOT PER SECOND, FURTHER LIMITED TO NO MORE THAN 4.8 ACRE-FEET PER YEAR

PERIOD OF USE: YEAR ROUND

DATE OF PRIORITY: SEPTEMBER 22, 1888

Measurement, recording and reporting conditions:

- A. The water user shall maintain the totalizing flow meter or other suitable measuring device, as approved by the Director, in good working order.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

B. The water user shall allow the watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices is located within a private structure, the watermaster shall request access upon reasonable notice.


The quantity of water diverted at the point of diversion shall not exceed the quantity of water lawfully available at the original point of diversion described as follows:

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.

This certificate is issued to confirm a change in CHARACTER OF USE approved by an order of the Water Resources Director entered JUNE 15, 2010, at Special Order Volume 81, Page 127, approving Transfer Application 10909, and supersedes Certificate 85481, State record of Water Right Certificates.
