CERTIFICATE OF WATER RIGHT

TRESTLE VIEW FARMS 9005 SW TRESTLE VIEW LANE MCMINNVILLE, OR 97128

confirms the right to use the waters of the SOUTH YAMHILL RIVER, a tributary of the YAMHILL RIVER, for IRRIGATION of 16.37 ACRES.

This right was perfected under Permit S-13718. The date of priority is MAY 15, 1939. The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 0.19 CUBIC FOOT PER SECOND (IF AVAILABLE AT THE AUTHORIZED POINT OF DIVERSION, DESCRIBED AS LOCATED WITHIN THE SE1/4 NW1/4, AS PROJECTED WITHIN EDSON DLC 38, SECTION 5, T 5 S, R 4 W, W.M.), or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
