This right was perfected by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 12 at Page 9. The priority dates are 1908 for 0.019 cfs and 10/1/1908 for 0.060 cfs.

The use is limited to 1.5 MINER'S INCHES PER ACRE, or 0.079 cubic foot per second, or its equivalent in case of rotation, measured at the point of diversion from the source.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described, and the right shall be subject to all other conditions and limitations contained in the above-described decree.
