This right was perfected under Permit S-5800. The priority date is 12/29/1922. The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 0.138 cubic foot per second (cfs) or its equivalent in case of rotation, measured at the point of diversion from the source.
