confirms the right to use the waters of KEITH CYRUS RESERVOIR constructed under Permit R-4807, for SUPPLEMENTAL IRRIGATION of 53.0 ACRES.

This right was perfected under Permit S-31702. The date of priority is DECEMBER 13, 1966. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 68.0 ACRE-FEET of stored water.

The points of diversion are located as follows:
