## CERTIFICATE OF WATER RIGHT

### THIS CERTIFICATE ISSUED TO:

Donald L. and Debra J. Slusarenko 53522 Hwy. 332 Milton-Freewater, OR 97862

confirms the right to use the waters of a WELL, tributary to the Walla Walla River for IRRIGATION on 4.82 ACRES.

This right was perfected under Permit U-149. The priority date is 10/28/1943. The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 0.0802 cubic foot per second (cfs) or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of appropriation is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-SIXTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be limited to a diversion of not to exceed 1 acre-foot per acre for each acre irrigated during any 30-day period and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season from April 1 to October 1. The use shall conform to such reasonable rotation system as may be ordered by the proper state official.

A description of the place of use to which this right is appurtenant is as follows:

This certificate is issued to correct a scrivener's error in the quantity listed described on Certificate 92809. This Certificate supersedes Certificate 92809, and describes the water right NOT modified by the provisions of an order of the Water Resources Director entered May 5, 2017, and recorded in Special Order Volume 104, Page 547, approving a petition by Walla Walla River Irrigation District under ORS 541.329 for mapping water rights within a district. This certificate supersedes Certificate 92809.

Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
