CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of a WELL, tributary of the Little Walla Walla River for SUPPLEMENTAL IRRIGATION on 0.65 ACRE.

This right was perfected under Permit G-4358. The priority date is 10/7/1968. The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 0.002 cubic foot per second (cfs) or its equivalent in case of rotation, measured at the point of diversion.

The point of appropriation is located as follows:

6 N	35 E	WM	34	NE SE	440 FEET SOUTH AND 140 FEET WEST FROM THE EAST ¼ CORNER OF SECTION 34

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH (1/80) of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion not to exceed 4.5 acre-feet per acre irrigated during the irrigation season of each year; provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein. The use shall conform to such reasonable rotation system as may be ordered by the proper state official.

A description of the place of use to which this right is appurtenant is as follows:

Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate supersedes Certificate 92853.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
