confirms the right to use the waters of the Little Walla Walla River, tributary of the Walla River for IRRIGATION on 8.71 ACRES.

This right was perfected under Permit S-26001. The priority date is 1/16/1959. The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 0.123 cubic foot per second (cfs) or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to 0.0375 (3/80) of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state official.

This certificate is issued to correct a scrivener's error in the location of the point of diversion, described on Certificate 92878. This Certificate supersedes Certificate 92878, and describes the water right NOT modified by the provisions of an order of the Water Resources Director entered May 5, 2017, and recorded in Special Order Volume 104, Page 547, approving a petition by Walla Walla River Irrigation District under ORS 541.329 for mapping water rights within a district. This certificate supersedes Certificate 92878.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for instream flows.
