CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CAROL WILLIAMS

confirms the right to use the waters of LAKE CREEK, for IRRIGATION of 44.5 ACRES, DOMESTIC AND STOCK USE.

The right was confirmed by decree of Circuit Court of the State of Oregon for Deschutes County and the said decree entered at Salem, in the Order Record of the Water Resources Director in Volume 9, at Page 362. The date of priority is 1888.

The amount of water to which this right is entitled for the purposes aforesaid is limited to an amount actually beneficially used for said purposes, and shall not exceed 3 acre-feet per acre measured at the point of diversion from the stream, which may be diverted at a rate of not to exceed 1/60<sup>th</sup> of one cubic foot per second during the irrigation season from May 1 to September 15; and shall be subject to all other conditions and limitations contained in said decree.

The points of diversion are located as follows:

A description of the place of use to which this right is appurtenant is as follows:

Prior to October 1, 2014, the water user shall install and maintain an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.


Prior to use of the water, the water user shall install and maintain fish screens or fish by-pass devices, as appropriate, at the new points of diversion. The type and plans of the screens or by-pass devices must be approved by the Oregon Department of Fish and Wildlife prior to beginning of construction, and shall be installed under the supervision of the Department of Fish and Wildlife.

This certificate describes that portion of water right Certificate 88891, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered September 24, 2018, approving Transfer Application T-12557.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
