## THIS CERTIFICATE ISSUED TO

## STATE OF OREGON WATER RESOURCES DEPARTMENT

confirms the right to use the waters of the LUCKIAMUTE RIVER, tributary to the WILLAMETTE RIVER, for instream use for conservation, maintenance and enhancement of aquatic and fish life, wildlife, fish and wildlife habitat and other ecological values.

The right was perfected by Permits S-19349 and S-45906. The dates of priority are March 8, 1950 and August 18, 1980.

The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 0.06 CUBIC FOOT PER SECOND (cfs), being 0.04 cfs under March 8, 1950 priority and 0.02 cfs under August 18, 1980 priority, or its equivalent in case of rotation, measured at the point of diversion, from June 1 through September 9.

The description of the stream point in which flows are to be maintained is as follows:

From the authorized point of diversion previously authorized under Certificates 31722 and 62149 located as follows:

Within the specified stream reach, the amount of water to which this right is entitled shall not exceed the quantity of water legally available at the original point of diversion. Stream channel losses and gains calculated based on available data and the use of water by senior appropriators will determine the amount of water to which this right is entitled downstream from the original point of diversion within the specified stream reach.

The instream right established by this conserved water application shall replace a portion of instream water rights established pursuant to ORS 537.341 or 537.346 and shall be in addition to instream water rights established pursuant to ORS 537.348 or 537.470 unless otherwise specified by a subsequent order establishing a new instream water right.
