CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of A WELL a TRIBUTARY of the WILLAMETTE RIVER, for IRRIGATION of 43.1 ACRES and SUPPLEMENTAL IRRIGATION of 71.3 ACRES.

This right was perfected under Permit G-10299. The date of priority is DECEMBER 28, 1983. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.94 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the well.

The point of appropriation (a well) is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of ONE-EIGHTIETH, of one cubic foot per second per acre, per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
