CERTIFICATE OF WATER RIGHT

confirms the right to the use of water perfected under the terms of Permit S-14294. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: MCKAY CREEK, A TRIBUTARY OF UMATILLA RIVER

PURPOSE OR USE: IRRIGATION OF 5.03 ACRES

MAXIMUM RATE: 0.095 CUBIC FOOT PER SECOND

DATE OF PRIORITY: APRIL 13, 1940

The point of diversion is located as follows:

Twp	Rng	Mer	Sec	Q-Q	Measured Distances
2 N	32 E	WM	21	NE SW	1310 FEET SOUTH AND 2577 FEET EAST, FROM THE 1/4 CORNER COMMON TO SECTIONS 20 AND 21

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per are for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by a proper state officer.

A description of the place of use is as follows:

The quantity of water diverted at the new point of diversion, together with that diverted at the old diversion, shall not exceed the quantity of water lawfully available at the original point of diversion described as follows:

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.

The water user shall maintain a fish screen or fish by-pass device.

Water shall be acquired from the same surface water source as the original point of diversion.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered April 1, 1998, at Special Order Volume 52, Page 294, approving Transfer Application 7168, and together with Certificate 75553, supercedes Certificate 53298, State record of Water Right Certificates.
