The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.

The water user shall maintain a fish screen or fish by-pass device.

Water shall be acquired from the same surface water source as the original point of diversion.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.

This certificate is issued to confirm a change in POINT OF DIVERSION AND PLACE OF USE approved by an order of the Water Resources Director entered April 1, 1998, at Special Order Volume 52, Page 294, approving Transfer Application 7168, and together with Certificate 75552, supercedes Certificate 72441, State record of Water Right Certificates.
