confirms the right to the use of water perfected under the terms of Permit G-9405. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the well(s). The specific limits and conditions of the use are listed below.

SOURCE OF WATER: TWO WELLS IN DUGGER CREEK BASIN

PURPOSE OR USE: IRRIGATION OF 4.5 ACRES (BROWN) AND SUPPLEMENTAL IRRIGATION OF 4.5 ACRES (CROUTHAMEL)

MAXIMUM RATE: 0.11 CUBIC FOOT PER SECOND (CFS), BEING 0.055 CFS FOR BROWN AND 0.055 CFS FOR CROUTHAMEL

DATE OF PRIORITY: SEPTEMBER 22, 1980 FOR 0.06 CFS AND AUGUST 6, 1981 FOR 0.05 CFS

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which this right is appurtenant, is as follows:



When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm changes in PLACE OF USE approved by an order of the Water Resources Director entered DECEMBER 17, 2005, at Special Order Volume 58, Page 356, approving Transfer Application 8303, and together with Certificate 80494, supersedes Certificate 65773, State record of Water Right Certificates.
