CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GUTIERREZ CATTLE CO.
PO BOX 1076
WEST SACRAMENTO CA 95691

confirms the right to use the waters of CAMP CREEK, a tributary of CROOKED RIVER for IRRIGATION of 13.8 ACRES.

This right was perfected under permit S-22142. The date of priority is FEBRUARY 23, 1953. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.205 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

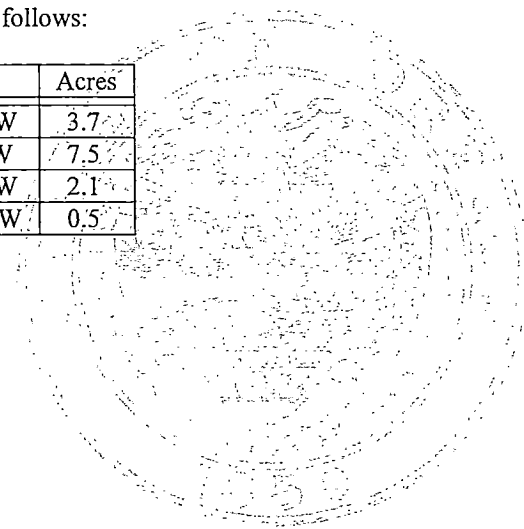
The point of diversion is located as follows:

Twp	Rng	Mer	Sec	Q-Q	Measured Distances
17 S	21 E	WM	1	SW SE	150 FEET NORTH AND 2720 FEET EAST FROM SW CORNER, SECTION 1

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:




NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered May 24, 2007, at Special Order Volume 72, Page 152, approving Transfer Application 10243, and together with Certificate 83299, supersedes Certificate 33374 State Record of Water Right Certificates.
