This right was perfected under by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 12 at Page 9. The priority dates are 1875, 1891, and 1901.

The use is limited to 1.0 MINER'S INCH PER ACRE, or 0.30 cubic foot per second (CFS), being 0.25 CFS under 1875 priority; 0.025 CFS under 1891 priority; and 0.025 CFS under 1901 priority, or their equivalents in case of rotation, measured at the point of diversion from the source.
