and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Lake

County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume

10

at page

227

that the priority of the right thereby confirmed dates from April 1, 1887 for Tract No.1; June 1,1889 for Tract No.2; June 1, 1908 for Tract No.3, and 1900 for Tract No. 4.

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed one-fortieth of a cubic foot per second per acre of land irrigated prior to June 15th, and one-eightieth of a cubic foot per second per acre of land irrigated after June 15th, of each year, with a total limitation during each irrigation season of three acre feet per acre.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:
