CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ESTATE OF ADDISON L. TULLEY
JESSE E. TULLEY, ADMINISTRATOR
WALLOWA, OREGON

confirms the right to use the waters of the WALLOWA RIVER, a tributary of the GRANDE RONDE RIVER, and the LOSTINE RIVER (aka SOUTH FORK WALLOWA RIVER), a tributary to the WALLOWA RIVER, for IRRIGATION OF 197.3 ACRES, DOMESTIC AND LIVESTOCK.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Wallowa County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 5 at Page 197. The dates of priority are 1907 for Tracts 1 and 2; 1900 for Tract 3, May 1893 for Tract 4, and 1897 for Tract 5.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.5 acre-feet per acre during any period of 30 days prior to July 31 of each year, and thereafter not to exceed 1.0 acre-foot per acre during the entire remainder of the irrigation season.
