CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RUSSELL YOUNG

confirms the right to use the waters of JOHN DAY RIVER, a tributary of the COLUMBIA RIVER, for IRRIGATION of 52.5 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Grant County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 15, at Page 461. The date of priority is 1872.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.31 cubic feet per second, per acre irrigated from April 1 to September 30; further limited to 1.0 acre-foot per acre calendar month to July 1, and 3/4 acre-foot per acre thereafter; total 5.0 acre-feet per acre for season, measured at the point of diversion.

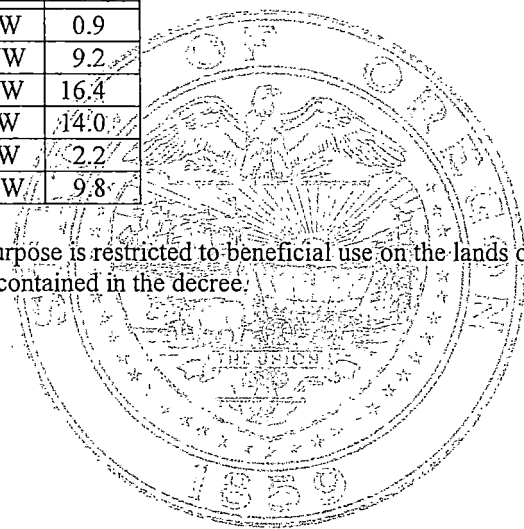

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.




**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered JANUARY 15, 2004, at Special Order Volume 59, Page 116, approving Transfer Application 9551, and together with Certificate 80556, supersedes Certificate 25853, State record of Water Right Certificates.
