CERTIFICATE OF WATER RIGHT

confirms the right to the use of water perfected under the terms of Permit S-50668. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point(s) of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: OLSON RESERVOIR, A TRIBUTARY OF SALT CREEK, CONSTRUCTED UNDER PERMIT R-6154, CERTIFICATE 51798

PURPOSE OR USE: IRRIGATION OF 6.4 ACRES AND SUPPLEMENTAL IRRIGATION OF 80.0 ACRES

MAXIMUM RATE: 1.08 CUBIC FEET PER SECOND (CFS), BEING 0.08 CFS FOR IRRIGATION OF 6.4 ACRES AND 1.0 CFS FOR SUPPLEMENTAL IRRIGATION OF 80.0 ACRES

DATE OF PRIORITY: JULY 8, 1988

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.


This right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
