The quantity of water diverted at the new points of appropriation shall not exceed the quantity of water lawfully available at the original point of appropriation.

Water shall be acquired from the same aquifer (water source) as the original point of appropriation.

Water use measurement conditions:

- a. The water user shall install a totalizing flow meter, or, with prior approval of the Director, another suitable measuring device at each (new and existing) points of appropriation.
- b. The water user shall maintain the meters or measuring devices in good working order.
- c. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.

This certificate confirms changes in points of appropriation and changes in place of use approved by the provisions of an Order of the Water Resources Director entered July 10, 2017; Special Order Volume 105, Page 242; approving Transfer Application T-11171, and supersedes Certificate 74668.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said permit.
