CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of the McKAY RESERVOIR, constructed under reservoir Permit R-584, a tributary of the McKAY CREEK, for SUPPLEMENTAL IRRIGATION OF 3028.4 acres of land served by the Stanfield Irrigation District.

This right was perfected under Permit 54406. The date of priority is MARCH 14, 2007.

The point of diversion is located as follows:

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season MARCH 1 THROUGH NOVEMBER 1 of each year.

The water user shall comply with the terms and conditions of a valid Water Contract between the Bureau of Reclamation and the water user. The Watermaster shall distribute water to the designated points of diversion according to ORS 540.410 and valid water service contracts as may be amended from time to time.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
