## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to the use of water perfected under the terms of Permit G-8235. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the well(s). The specific limits and conditions of the use are listed below.

SOURCE OF WATER: TWO WELLS, TRIBUTARY TO WALLA WALLA RIVER

PURPOSE OR USE: SUPPLEMENTAL IRRIGATION OF 9.8 ACRES

MAXIMUM RATE: 0.25 CUBIC FOOT PER SECOND (CFS), BEING NO MORE THAN 0.25 CFS FROM WELL 1

AND 0.20 CFS FROM WELL 2, MAXIMUM CUMULATIVE TOTAL NOT TO EXCEED 0.25 CFS

DATE OF PRIORITY: JUNE 29, 1978

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

## NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Water use measurement conditions:

- A. The water user shall maintain the totalizing flow meter or other suitable measuring device as approved by the Director in good working order at each point of appropriation.
- B. The water user shall allow the watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the watermaster shall request access upon reasonable notice.

The existing well (Well 1) shall be reconstructed to current well construction standards so that it accesses only the alluvial aquifer.

The new well (Well 2) shall be cased and sealed in such a manner that it meets well construction standards and develops a single basalt aquifer.

The quantity of water diverted at the additional point of appropriation, together with that diverted at the original point of appropriation, shall not exceed 0.25 CFS, being from Well 1 (accessing the alluvial aquifer), with any deficiency in supply from Well 2 (accessing the basalt aquifer).

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.

This certificate is issued to confirm an ADDITIONAL POINT OF APPROPRIATION approved by an order of the Water Resources Director entered SEPTEMBER 10, 2010, at Special Order Volume 81, Page 854, approving Transfer Application 10849, supersedes Certificate 55017, State record of Water Right Certificates.
