NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This right was perfected under Permit 44349 for water stored under permit R-7916 in Howard Prairie Reservoir. The date of priority is AUGUST 24, 1978. This right is limited to no more than 600 ACRE FEET OF STORED WATER FOR THE CITY OF ASHLAND, TO BE RELEASED FROM HOWARD PRAIRIE RESERVOIR DURING THE PERIOD OF APRIL 1 THROUGH OCTOBER 31 OF EACH YEAR. The water is delivered through the Talent Irrigation District facilities as provided by agreements dated March 21, 1924; December 7, 1926; November 2, 1937; June 21, 1966, and Contract No. 8-07-10-w024, and is subject to the terms and conditions of said agreements and contracts or their satisfactory replacements.


The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered FEBRUARY 2, 2018, at Special Order Volume 107, Page 573, approving Transfer Application 12685, supersedes Certificate 80462, State record of Water Right Certificates.
