 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MOONSHINE DITCH CO.
 JOSEPH, OR 97846

confirms the right to use the waters of HURRICANE CREEK, a tributary of the WALLOWA RIVER for the purpose of the IRRIGATION OF 697.84 ACRES OF LAND, DOMESTIC AND STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Wallowa County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 5, at Page 186 and 187. The date of priority is 8:00 A.M, November 30, 1901.

The amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1½ acre feet per acre during any period of 30 days prior to July 31st of each year, and thereafter not to exceed 1 acre foot per acre during the entire remainder of the irrigation season.


