CERTIFICATE OF WATER RIGHT

EVERETT L HEIKES RT 1 CORNELIUS, OREGON

confirms the right to use the waters of the EAST DAIRY OF CREEK, tributary of TUALATIN RIVER, for IRRIGATION OF 30.4 ACRES AND SUPPLEMENTAL IRRIGATION OF 19.6 ACRES.

This right was perfected under Permit S-13404. The date of priority is DECEMBER 19, 1938. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 0.63 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the points of diversion from the stream.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:


The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
