CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

U.S. BUREAU OF LAND MANAGEMENT 3040 BIDDLE RD MEDFORD OR 97504

confirms the right to use the waters of APPLEGATE RIVER, TRIBUTARY TO ROGUE RIVER for IRRIGATION of 21.7 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for JACKSON County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 16, at Page 523. The date of priority is OCTOBER 1898.

The amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.122 cubic foot per second; further limited to a maximum rate of 1/178 cubic foot per second per acre.

The point of diversion (hydraulically connected well) is located as follows:

Beginning at the NW corner of the NE¼ NE¼, Section 12, T. 38 S., R. 5 W., W.M., thence South along the West line of said NE¼ NE¼ a distance of 70 rods; thence East 80 rods to the East line of said Section 12; thence North to the NE corner of said Section 12; thence West along the North line of said Section 12 to the point of beginning, less and excepting the following-described tract:

Beginning at the NE corner of said Section 12 and running thence South 355 feet on the section line; thence West 55 feet to the point of beginning; thence West 75 feet; thence South 50 feet; thence East 75 feet; thence North 50 feet, to the point of beginning.

Also less and excepting a tract of land described as follows: Beginning 214 feet South of the NE corner of said Section 12 on county line; thence West 150 feet; thence South 70 feet; thence East 150 feet to county line; thence North on county line 70 feet to beginning.

The water user shall maintain an in-line flow meter, weir, or other suitable measuring device for measuring and recording the quantity of water diverted.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a change in POINT OF DIVERSION FROM SURFACE WATER TO GROUND WATER approved by an order of the Water Resources Director entered December 18, 2006, at Special Order Volume 70, Page 738, approving Transfer Application 9726 and CW-36, and together with Certificates 82893, 82901, and 94326, supercedes Certificate 32820, State record of Water Right Certificates.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.
