CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

U.S. BUREAU OF LAND MANAGEMENT 3040 BIDDLE RD MEDFORD OR 97504

confirms the right to use the waters of APPLEGATE RIVER, TRIBUTARY TO ROGUE RIVER for IRRIGATION of 44.0 ACRES, MAINTENANCE OF STONE RESERVOIR, and ROAD CONSTRUCTION AND PRESCRIBED FIRE ACTIVITIES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for JACKSON County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 16, at Page 523. The date of priority is OCTOBER 1898.

The amount of water to which this right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.325 CUBIC FOOT PER SECOND (CFS) BEING; 0.252 CFS FOR IRRIGATION, 0.067 CFS FOR MAINTENANCE OF STONE RESERVOIR, and 0.006 CFS FOR ROAD CONSTRUCTION AND PRESCRIBED FIRE ACTIVITIES. The use of water for irrigation is further limited to a maximum rate of 1/175 cubic foot per second per acre.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Prior to water being used for road construction and prescribed fire activities, the water user must specify where the water is to be used, and approval must be obtained from the Department.

The water user shall maintain an in-line flow meter, weir, or other suitable measuring device for measuring and recording the quantity of water diverted.

The use of water under this right was perfected under CW-36. For purposes of future transfers, it is not the intention to permanently layer this water right with any other right existing for the same lands. Therefore, this water right is not subject to the layered water right restrictions contained in ORS 540.510(1). Upon transfer of title to the lands to which this right is appurtenant, this right shall be subject to ORS 537.490(3).

This certificate is issued to confirm a change in CHARACTER OF USE, POINT OF DIVERSION FROM SURFACE WATER TO GROUND WATER, AND THE APPLICANTS PORTION OF THE CONSERVED WATER approved by an order of the Water Resources Director entered December 18, 2006, at Special Order Volume 70, Page 738, approving Transfer Application 9726 and CW-36, and together with Certificates 82891, 82892, 82893, and 82901, 94323, 94324, and 94325, supercedes Certificate 32813, 32818, and 32820, State record of Water Right Certificates.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.
