CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN A BAGGENSTOS ROUTE 4, BOX 403 SHERWOOD, OR

confirms the right to use the waters of TUALATIN RIVER and an unnamed stream, a tributary of TUALATIN RIVER and WILLAMETTE RIVER for the purpose of IRRIGATION of 155.7 ACRES.

This right was perfected under Permit S-21065 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from JANUARY 30, 1952, that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.69 CUBIC FEET PER SECOND (cfs), being 1.44 cfs from Tualatin River and 0.25 cfs from unnamed creek, or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
