confirms the right to the use of water perfected under the terms of Permit S-33944. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point(s) of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: SNAKE RIVER, A TRIBUTARY TO THE COLUMBIA RIVER

PURPOSE OR USE: IRRIGATION OF 52.8 ACRES

MAXIMUM RATE: 0.698 CUBIC FOOT PER SECOND (CFS)

DATE OF PRIORITY: OCTOBER 25, 1968

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of 1/75.61 of one cfs, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The right to the use of the water for the above purpose is restricted to beneficial use on the land or place of use described.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered DECEMBER 8, 2015, at Special Order Volume 98, Page 431, approving Transfer Application 11978, and together with Certificate 91031, supersedes Certificate 85585, State record of Water Right Certificates.
