 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of DEER RIDGE WELL, LISKEY WELL, AND MITCHELL WELL, in the KLAMATH BASIN for IRRIGATION of 49.0 ACRES.

This right was perfected under Permit G-10129. The date of priority is AUGUST 31, 1982. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.59 CUBIC FOOT PER SECOND (CFS), BEING 0.57 FROM DEER RIDGE WELL, 0.01 CFS FROM LISKEY WELL, AND 0.01 CFS FROM MITCHELL WELL, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:

The wells shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the wells at all times. The water user shall install and maintain a weir, meter, or other suitable measuring device and keep a complete record of the amount of ground water withdrawn.

This right is for beneficial use of water.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

This certificate describes that portion of water right Certificate 87741, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered DEC 18 2019, approving Transfer Application T-11841.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

The use of water shall be limited when it interferes with any prior surface or ground water rights.
