## CERTIFICATE OF WATER RIGHT

## THIS CERTIFICATE ISSUED TO

TIMOTHY AND SUZANNE KREDER 11700 SE AMITY DAYTON HWY DAYTON, OR 97114

confirms the right to use the waters of AN UNNAMED STREAM AND RESERVOIR CONSTRUCTED UNDER PERMIT R-11247, tributaries of WEST FORK PALMER CREEK, for IRRIGATION OF 122.5 ACRES.

This right was perfected under Permit S-51073. The date of priority is JUNE 6, 1990. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 1.53 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage. The use of water from direct flow is limited to the irrigation season prior to June 1 of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
