CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of the SOUTH UMPQUA RIVER, a tributary to the UMPQUA RIVER, for IRRIGATION of 30.0 ACRES.

This right was perfected under Permit S-11867. The date of priority is SEPTEMBER 18, 1935. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.26 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-ONE HUNDRED FIFTEENTH (1/115) of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 1.74 acre-feet per acre for each acre irrigated during the irrigation season of each year, and an annual volume limitation of 52.2 Acre-Feet. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
