## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LEONARD TERRY 6226 UPPER COW CREEK AZALEA OR 97410

confirms the right to use the waters of THREE UNNAMED STREAMS AND FOUR RESERVOIRS, CONSTRUCTED UNDER PERMIT R-7800, tributaries of COW CREEK, AND COW CREEK, a tributary of the UMPQUA RIVER, for DOMESTIC USE FOR TWO FAMILIES INCLUDING THE IRRIGATION OF NOT TO EXCEED ½ ACRE LAWN AND GARDEN FOR EACH, DOMESTIC USE FOR ONE FAMILY, AND IRRIGATION of 31.1 ACRES.

This right was perfected under Permit 43944. The date of priority is DECEMBER 12, 1978. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.46 CUBIC FOOT PER SECOND (CFS), BEING 0.01 CFS FROM UNNAMED STREAM 1 FOR DOMESTIC USE FOR TWO FAMILIES INCLUDING THE IRRIGATION OF NOT TO EXCEED ½ ACRE LAWN AND GARDEN, 0.005 CFS FROM UNNAMED STREAM 2 FOR DOMESTIC USE FOR ONE FAMILY, 0.445 CFS IN ANY COMBINATION FOR IRRIGATION, BEING 0.375 CFS FROM UNNAMED STREAM 2 AND RESERVOIRS 1, 2 AND 3, 0.225 CFS FROM UNNAMED STREAM 3 AND RESERVOIR 4, WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY OF WATER FOR IRRIGATION TO BE MADE UP BY DIVERSION FROM COW CREEK.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate at any time before it has issued, and after the time has expired for the completion of the appropriation under the permit, or within three months after issuance of the certificate.
