CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JAMES T. CLARK

confirms the right to use the waters of JOHN DAY RIVER, TRIBUTARY TO COLUMBIA RIVER for IRRIGATION of 82.3 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Grant County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 15, at Page 461. The date of priority is 1876.

The amount of water to which this right is entitled, for the purpose aforesaid, is limited to an amount actually beneficially used for said purpose, and shall not exceed 1/40 cubic foot per second (cfs) per acre irrigated at the original point of diversion and 0.70 cfs from the additional point of diversion, in any combination, from April 1 to September 30; further limited to one acre-foot per acre per calendar month to July 1 and 3/4 acre-foot per acre thereafter; total of five acre-feet per acre for season, measured at the point of diversion.

The points of diversion are located as follows:

A description of the place of use is as follows:

The quantity of water diverted at the additional point of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water available at the old point of diversion.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW


This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.

This certificate is issued to confirm AN ADDITIONAL POINT OF DIVERSION approved by an order of the Water Resources Director entered June 12, 1991, at Special Order Volume 45, Page 306, approving Transfer Application T-6480, and together with Certificate 66070, supercedes Certificate 25187, State record of Water Right Certificates.
