CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of STEWART CREEK, AND 2 RESERVOIRS CONSTRUCTED UNDER PERMITS R-1422 AND R-1423, a tributary of CROOKED RIVER for the purpose of IRRIGATION of 7.5 ACRES.

This right was perfected under Permit S-21721. The date of priority is APRIL 5, 1950.

The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 0.05 CUBIC FOOT PER SECOND, from Stewart Creek and reservoirs, if available at the original point of diversion in the NE 1/4 NE 1/4, Section 9, T17S, R12E, WM or its equivalent in case of rotation, measured at the point of diversion from the stream.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 4 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoirs constructed under Permits R-1422 and R-1423 and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
