CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

PRINEVILLE LAND AND LIVESTOCK COMPANY
PRINEVILLE, OR 97754

confirms the right to use the waters of DEEP CREEK, a tributary of NORTH FORK CROOKED RIVER for IRRIGATION of 1099.3 ACRES, STOCK AND DOMESTIC USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Crook County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 1, at Page 449. The date of priority is 1893.

The use is limited to 13.76 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water is limited to an amount actually beneficially used for said purposes and shall not exceed a reasonable amount for domestic and stock use and shall be further limited to a diversion of not to exceed 4.0 acre-feet for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:


